

CERTIFIED TRANSLATION FROM THE POLISH LANGUAGE

Information clause

Pursuant to Article 13 section 1 and 2 of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of individuals with regard to the processing of personal data and on the free movement of such data and repealing Directive 95/46 EC (hereinafter: GDPR) , we inform you as follows:

- * The administrator of your personal data is the Regional Directorate of State Forests in Krosno with its registered office at ul. Bieszczadzka 2, 38-400 Krosno, tel. 13-43-73-900, e-mail address rdlp@krosno.lasy.gov.pl
- * The Regional Directorate of State Forests in Krosno has not appointed a Personal Data Protection Inspector.
- * Your personal data is processed for the purposes of hunting organization and service, in particular in order to issue authorization to perform hunting, to keep a record book of the hunter's stay in the hunt, as well as to fulfill other legal obligations connected with the safety of hunting and meeting the conditions for hunting, as well as to determine, investigate and defend against claims.
- * The legal basis for the processing of your personal data is art. 6 section 1 subsection C GDPR - processing is necessary to comply with the legal obligation incumbent on the administrator, Act of 28 September 1991 on forests, Act of 13 October 1995 Hunting Law, Regulation of the Minister of the Environment of 23 March 2005 on detailed conditions for hunting and marking carcasses, art. 6 section 1 subsection f GDPR the administrator's legitimate interest.
- * Your personal data will be stored for a period of time:
 - * determined by the provisions of the Civil Code on limitation of claims - the basic period of six years from the date of payment of the claim;
 - * for the purposes of accounting and for tax reasons, we process data for a period of 5 years counted from the end of the calendar year in which the tax obligation arose;
 - * designated by regulations (including internal) on archiving documents - depending on which of these periods will be the longest.

In the field of personal data processing, you have the following rights:

- * **access to the content of your data** - by exercising this right you have the opportunity to obtain information, what data, how and for what it is processed;
- * **the right to rectify them** - using this right, you can report to us the need to correct incorrect data or supplement the data resulting from an error in the collection or processing of data;
- * **the right to delete** - using this right you can submit a request to delete data. If the request is justified, we will delete the data immediately. This right does not apply, however, when personal data are processed for purposes related to the fulfillment of the Administrator's legal obligations or to perform a task carried out in the public interest or as part of the public authority entrusted to administrator;
- * **right to restriction of processing** - using this right, you can apply for restriction of data processing if you question the correctness of the data being processed. If the application is justified, we can only store data. Unblocking of processing can take place after cessation grounds justifying the restriction of processing;
- * **the right to object** - using this right you can at any time object to the processing of your data if they are processed on the basis of art. 6 section 1 subsection e or f (legitimate interest or public interest). After accepting the application in this matter, we are obliged to stop processing data for this purpose. In such a situation, after examining your application, we will no longer be able to process the objectionable personal data on this basis, unless we prove that there are valid legitimate grounds for data processing, which according to the law are considered superior to your interests, rights and freedoms or grounds for determining, pursuing or defending claims.
- * You have the right to lodge a complaint to the supervisory body, i.e. to the President of the Office for Personal Data Protection, if you feel that the processing of your personal data violates the law.
- * Your personal data will not be processed in an automated manner (including in the form of profiling).
- * Your personal data will not be transferred to a third country or international organization.

- * Your data will be made available to data recipients in situations resulting from legal provisions. Your personal data will be made available to the State Forests Breeding Centers in the Regional Directorate of State Forests in Krosno.
- * In some situations, your personal data may be shared if it is necessary to perform the Administrator's statutory tasks. The administrator may disclose your personal data to
